- 4) **Out of State Manufacturers:** Nonresident dealers must provide name, address and evidence of authority to do business in the dealer's home state or country, such as a nonresident's business name and address, sales tax registration number, occupational license number, or any other evidence of transacting business in that state or country. **Form #1 Attached plus a copy of Exemption Certificate**

All Other Buyers will be subject to Florida State Sales Tax unless you provide us with an acceptable exemption certificate accepted by the state of Florida.
